46	Bursa Malaysia is encouraging all public listed companies to adopt good ESG practices in their business operations. What is our Company's annual budget in terms of percentage of total expenditure in pursuing the ESG agenda?
ANSWER	

We have allocated annual OPEX budget of more than RM3 million which is equivalent to 0.1% of total OPEX. We also plan to spend a sizeable CAPEX in FY2021 which supported the ESG practices e.g. cleaner fuels (biodiesel), premium fuel (ron97 with pro-race) etc.

Is it justify to ask for approval to increased Directors fees when company does not increase 47 its revenue as compared to previous years? What is your KPI on the profitability of the company?

ANSWER

The increase is mainly due to the higher anticipated number of the Board's and Board Committees' meetings until the conclusion of FY2022 AGM.

KPI is designed to ensure profitability is maximized which will safeguard shareholders value. This KPI is carried by MD/CEO and management team which will determine their performance.

PDB has a clear commitment to safeguarding the environment in our policies, which cover climate change issues and energy use. In looking at alternative energy to reduce our carbon footprint, PDB has installed solar panels at 8 of our station in FY2020 and plans to install solar panels at an additional ~70 retail stations in 2021. We also look at our social responsibility to our community such as Water for Life, bring fresh and clean water to underserved communities in rural Malaysia. We continue to look at other ways to reduce our overall carbon footprint.

Is the company pursuing sale of alternative energy e.g. sale of solar energy etc to improve its bottom line?

ANSWER

For alternative energy, LNG has been part of PDB products portfolio. LNG is an alternative cleaner fuel which is non-corrosive and produce less carbon emission (Clean Air Regulation 2014) as compared to Diesel/Fuel Oil & LPG which also supports our sustainability agenda. In relation to solar energy, we target to have ~70 solar panel installed at our stations by end of FY2021 from 8 stations installed in FY2020.

PDB shall continuously review its portfolio and open to new opportunities in alternative energy investment, if there is strategic fit and synergy that leads to value creation to our shareholders.

Why E-Wallet not available as a payment option at Petronas Stations?

ANSWER

A seamless and frictionless customer experience is what we wanted to give our customers and Setel does this as Malaysia's first mobile app that integrates fuel payment, retail and loyalty benefits - it allows users to purchase fuel and Kedai Mesra items using their mobile phones right from the comfort of their vehicles.

We have allocated a sizeable CAPEX and OPEX budget to modernize and upgrade our retail stations with world class IT systems and also to cloud enable our infrastructure, data center and network components to ensure high level of security, reliability and availability at all times. In addition, these initiatives and upgrades would enable us to run analytic in order to get to a level of personalisation for us to serve our customers better and create the seamless and frictionless customer experience.

In relation to the 15-inch interactive touch screen, this create value to PDB as it will provide space for advertisement for both PDB and its partners.

Company's total revenue declined from RM30.3B in FY2019 to RM18.7B this FY2020; what is the outlook on revenue and profitability going forward?

Also the ratio of revenue between retail segment and commercial segment has changed respectively from 40:60 to 49:51. What does this ratio change signify and does it mean that our company has lost market share to competitors?

What % of your retail stations have improved performance, and does increasing capex bring commensurate returns improvements?

ANSWER

For FY2021 outlook, PDB saw demand recovery in Q1 FY2021 as supported by the roll out of vaccine nationwide and increase in activities. However, the outlook remain uncertain as daily COVID-19 cases are still rising in Malaysia.

The change in ratio for FY2020's results was due to demand destruction for aviation industry where PDB saw a reduction in aviation volume of approximately ~65% in FY2020 as compared to FY2019. The change in contribution ratio does not necessarily equate to loss in market share.

The drop in FY2020 retail station performance is in line with overall industry decline due to the pandemic and various lockdowns throughout the year. Despite this, the retail segment still returned a commendable performance for both fuel and nonfuel business.
